Recent Decisions

Court of Appeal Affirms Commission Decision Partially Approving Test Claim (Opinion Certified for Publication on January 4, 2021)

REMAND OF State of California Department of Finance, State Water Resources Control Board, and California Regional Water Quality Control Board, Los Angeles Region v. Commission on State Mandates and County of Los Angeles Second District Court of Appeal, Case No. B292446

Municipal Storm Water and Urban Runoff Discharges,
03-TC-04, 03-TC-19, 03-TC-20, and 03-TC-21 (Los Angeles Regional Quality Control Board Order No. 01-182, Permit CAS004001, Parts 4C2a., 4C2b, 4E & 4Fc3)

The Court found that the permit provisions requiring inspections of commercial, industrial, and construction sites and installing and maintaining trash receptacles at transit stops impose a new program or higher level of service since the requirements are unique to government and provide a governmental service to the public. The court also agreed that the claimants have fee authority within the meaning of Government Code section 17556(d) for the inspection activities and, thus, those activities are denied. However, claimants (the County of Los Angeles and cities within the County) do not have fee authority to impose charges, fees, or assessments on transit districts or adjacent property owners to cover the cost to install and maintain trash receptacles at transit stops based on the authority cited by the State (Health and Safety Code section 5471; Government Code section 54999.7; police power under article XI, section 7 and article XIII D, section 6 of the California Constitution, and Government Code sections 53750 et seq.; and Public Resources Code section 40059). Therefore, the activities to install and maintain trash receptacles at transit stops constitute reimbursable state-mandated activities.
