
For its analysis of this test claim, staff requests additional information regarding the following alleged activities:

- Reporting exam results – specify and provide documentation regarding which activities are performed by the school or school district, and which are performed by the publisher of the exam.
- Data evaluation – specify and provide documentation regarding the activities required of the school districts, including those imposed by the Department of Education, for evaluating the exam data,

If you plan to amend this test claim, please provide the requested information on these activities in the amendment. If you do not plan to amend this test claim, please provide the requested information within 30 days of the date of this letter. Please direct your response to Eric Feller, Commission Counsel, and provide a copy of your response to the current mailing list. (Cal. Code Regs., tit. 2, § 1181.2, subd. (b).) The Department of Finance and affected state agencies will be given an opportunity to comment before an analysis is prepared. (Cal. Code Regs., tit. 2, § 1183.02, subd. (b).)
