Re: Notice of Complete Test Claim Filing, Consolidation and Schedule for Comments –
*Postmortem Examinations: Unidentified Bodies, Human Remains (02-TC-39) and DNA
Data Base (OO-TC-27)*

On June 25, 2003, the County of Los Angeles filed a proposed amendment to the *Postmortem Examinations: Unidentified Bodies, Human Remains* (OO-TC-18) test claim. Following initial review, the Commission staff found the proposed amendment to be complete.

The original test claim on this matter is scheduled for hearing on July 31, 2003. The proposed amendment is being severed from the original test claim (OO-TC-18), established as a new test claim (02-TC-39), and consolidated with the test claim filed by the County of San Bernardino titled DNA Data Base (OO-TC-27). The DNA Data Base test claim alleges the same code sections as the proposed amendment. The Commission is now requesting state agencies and interested parties to comment on it as specified in the enclosed notice.

Government Code section 17530 authorizes the executive director to expedite matters within the jurisdiction of the Commission. The original test claim on this matter has been fully analyzed by Commission staff, and the test claim can be decided without reference to the proposed amendment. Therefore, severing the test claim and the test claim amendment will prevent the hearing on the original test claim from being delayed.

The claimant may appeal any decision of the Executive Director to the Commission pursuant to California Code of Regulations, title 2, section 118 1, subdivision (c).
