The proposed schedules for the September or November 2009 or January 2010 Commission hearings are attached.

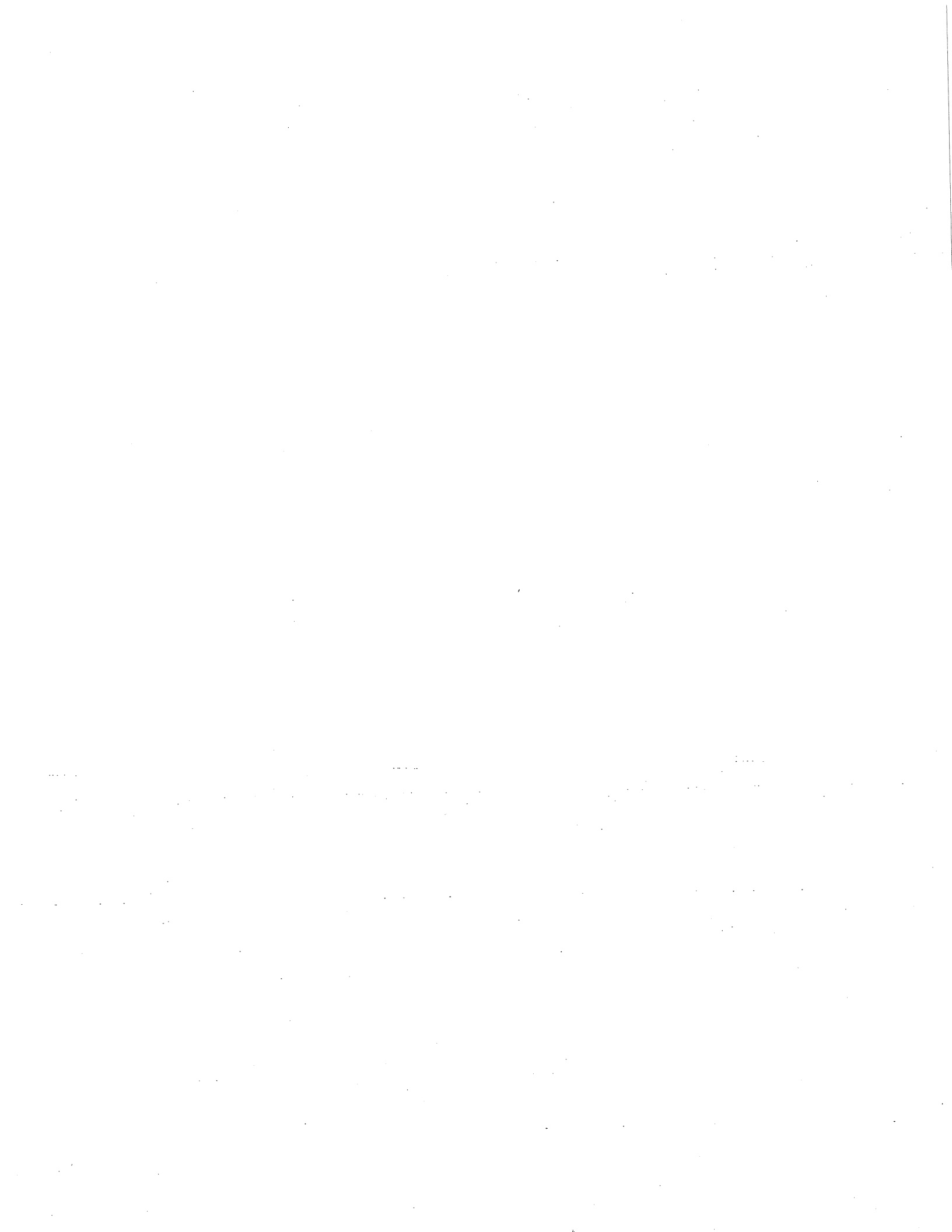
