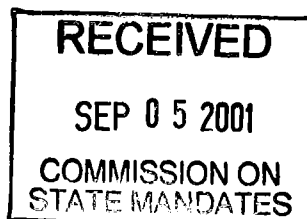

Pursuant with Title 2, Division 2 Financial Operations, Chapter 2.5.
