

The Department of Finance has received your letter dated July 14, 2003, requesting our review of the test claim submitted by the Santa Monica Community College District, asking the Commission to determine whether specified costs incurred under referenced sections of the Education Code, Title 2 Regulations, statutes and executive orders are reimbursable State mandated costs (Claim No. CSM-02-TC-48 "Deferred Maintenance"). In addition, we have received your letter dated July 15, 2003, requesting our review of the test claim submitted by the Clovis Unified School District, asking the Commission to determine whether specified costs incurred under referenced sections of the Education Code, Title 2 Regulations, statutes and executive orders are reimbursable State mandated costs (Claim No. CSM-02-TC-44 "Deferred Maintenance Programs"). Due to the coordination involved in performing these analyses, and the numerous activities for which the school district and the community college district are seeking reimbursement, we are requesting representation from the Attorney General's Office. As a result, we respectfully request an extension of at least 30 days to prepare our response.


