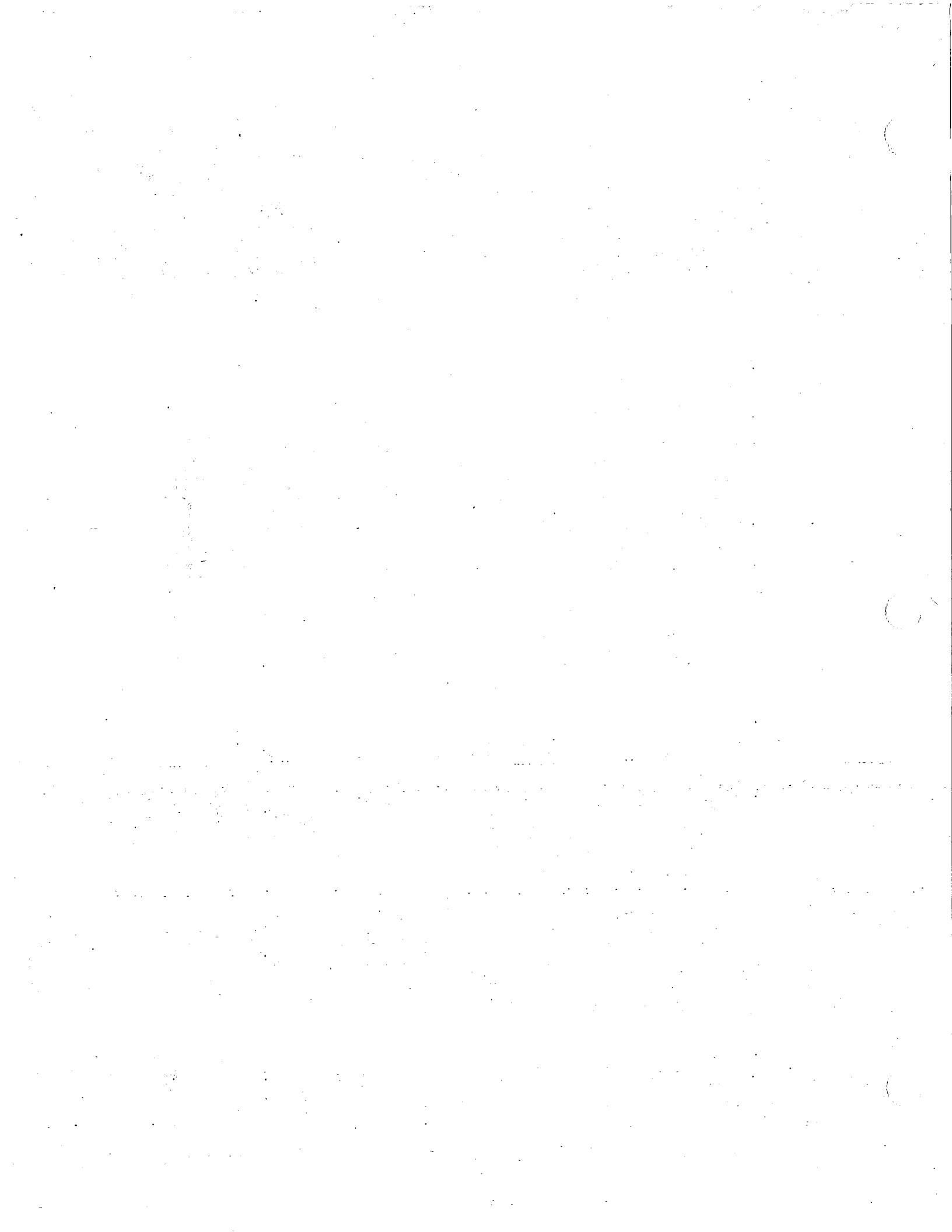

**EXECUTIVE SUMMARY**

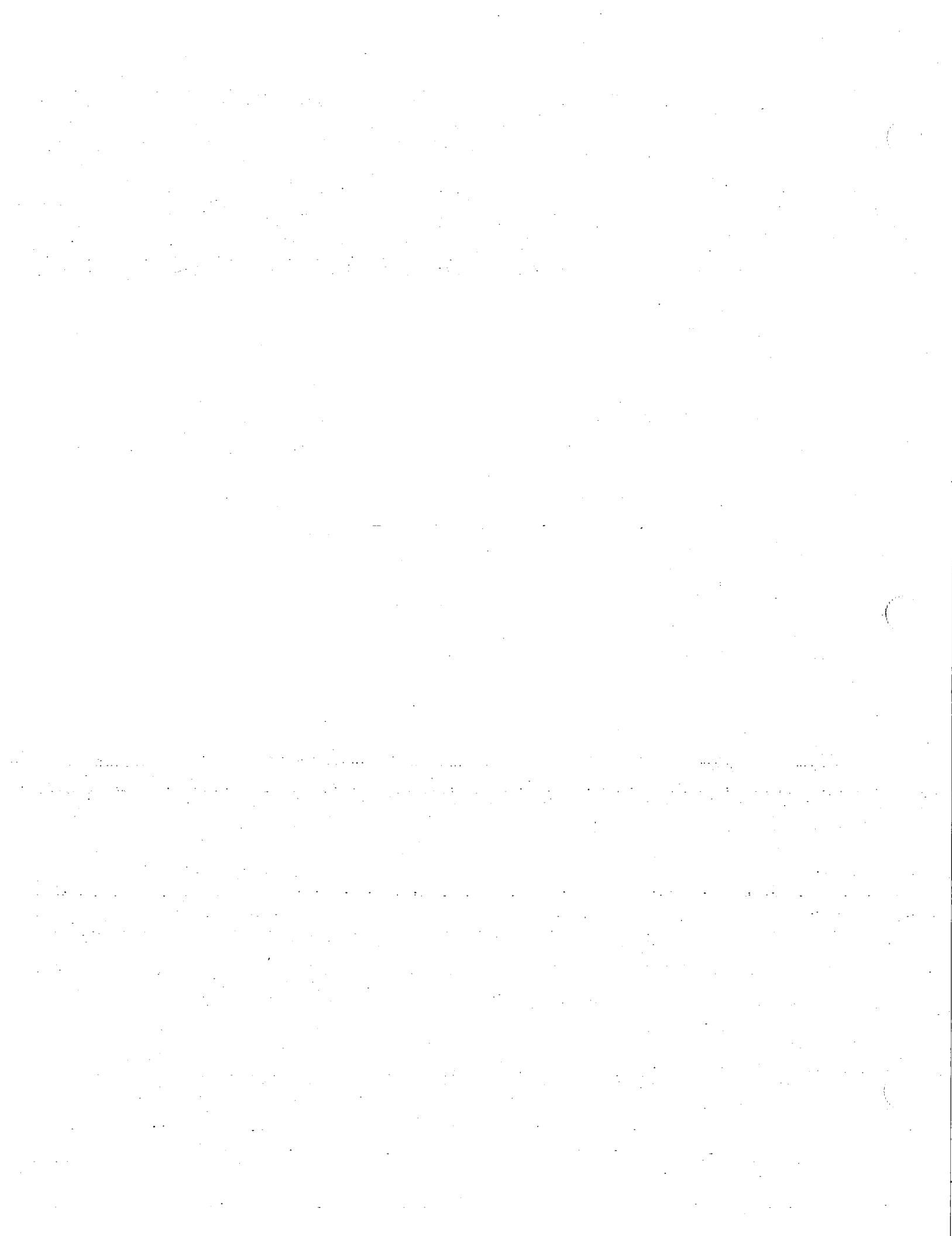
