Dear Mr. Petersen:

After review of *Disabled Student Programs and Services (02-TC-22)* and *Minimum Conditions for State Aid (02-TC-25 and 02-TC-31)*, it has been determined that both test claims have pled California Code of Regulations, title 5, sections 55522 and 55602.5, which address student matriculation and vocational education programs, respectively. However, in *Disabled Student Programs and Services*, the claim is limited to disabled students, while in *Minimum Conditions for State Aid* the claim addresses sections 55522 and 55602.5 in light of the whole administrative scheme, including its applicability to disabled students.

For the sake of efficiency, California Code of Regulations, title 5, sections 55522 and 55602.5 will be severed from West Kern Community College District's *Disabled Student Programs and Services* test claim and consolidated with the *Minimum Conditions for State Aid (and Notices to Students)* test claim. This action is being taken pursuant to my authority under Government Code section 17530 and California Code of Regulations, title 2, section 1183.06, and will be effective 10 days from the service of this letter.

All future references to the *Minimum Conditions for State Aid* test claim will include West Kern Community College District as a co-claimant with Los Rios Community College District and Santa Monica Community College District. A consolidated mailing list is enclosed.

As provided in the Commission's regulations this action and decision of the executive director may be appealed to the Commission for review. Please refer to California Code of Regulations, title 2, section 1181, subdivision (c).
