Hearing

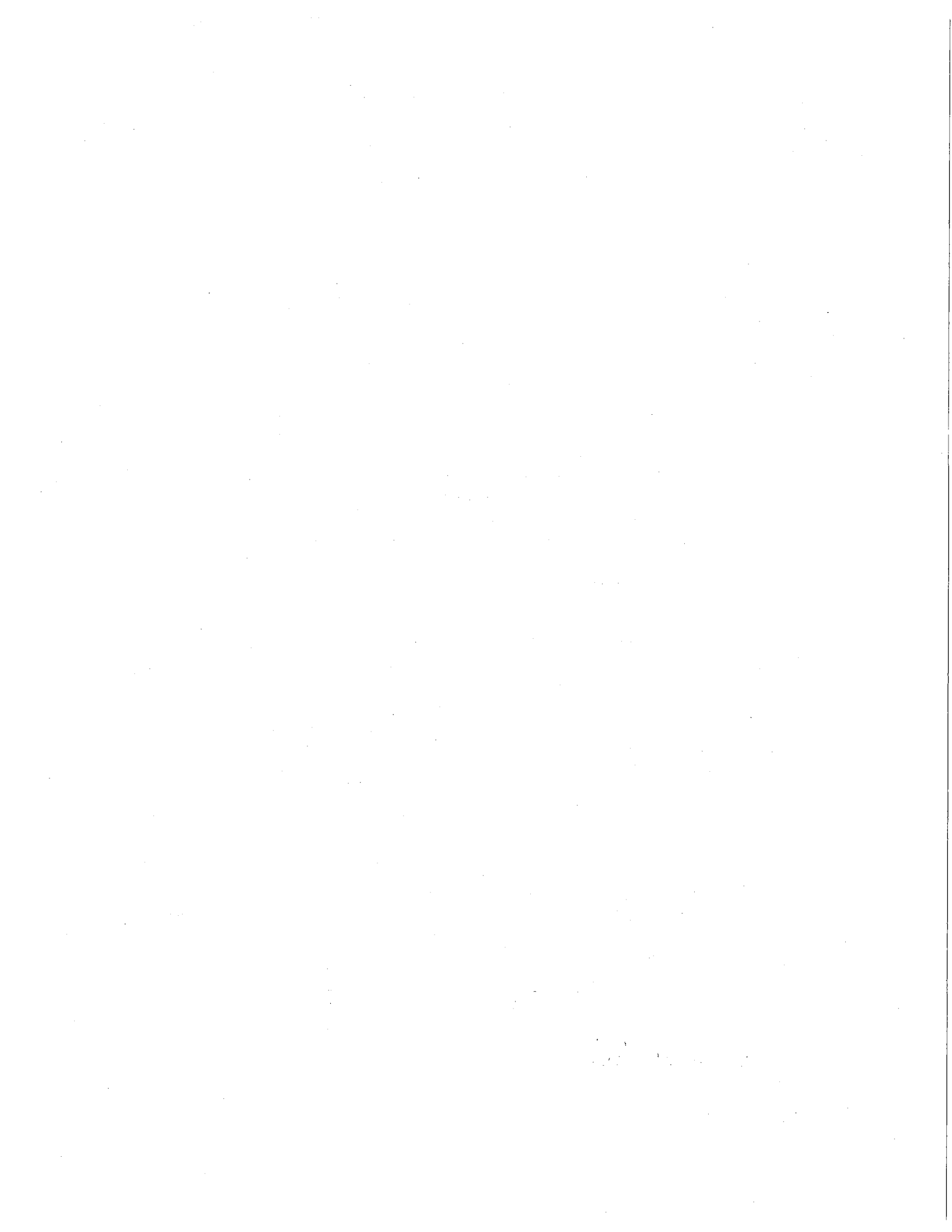
