Dear Mr. Spano, Mr. Petersen, and Ms. Kanemasu:

On July 17, 2015 the Commission on State Mandates (Commission) received a request from the State Controller's Office (SCO) for a second extension of time from July 17, 2015 to August 7, 2015 to provide comments on the above-named matter.

Specifically, the request states that additional time is required to respond to the complex legal issues involved in the draft proposed decision that was issued on May 27, 2015. Previously, the SCO's extension request and postponement of hearing from July 24, 2015 to September 25, 2015 was granted for good cause, pursuant to section 1187.9 (a) and (b) of the Commission's regulations. Currently, this matter is set for hearing on September 25, 2015.

Section 1187.9(a) of the Commission's regulations provides that so long as a postponement of a hearing would not be required, there is no prejudice to any party or interested party, and there is no other good reason for denial, the request shall be approved.

Therefore, your second request for extension of time to submit comments is approved for good cause. Comments are now due on or before **August 7, 2015**. Please note that requests for extensions beyond that date will be disfavored, as they would delay the hearing of this matter for a second time.
