#### Dear Ms. Donovan:

On July 23, 2014, the Commission on State Mandates (Commission) received your request to postpone the July 25, 2014 hearing on the above-named matter.

Pursuant to section 1187.9(b)(3)(C) of the Commission's regulations, a request to postpone filed by the claimant less than fifteen (15) days before the hearing *may* be approved for good cause. Continuances and postponements are disfavored and pursuant to Government Code section 17530, the executive director has a duty to expedite all matters before the Commission. Your request notes that "[t]he staff member who the District will rely on to support its claim is unavailable on the hearing date and requires additional time to prepare for the hearing." The request also states that there are "new staff in several key positions who will need to extensively research the claim history and underlying processes in order to be prepared for hearing."

This matter was set for hearing and the draft proposed decision was issued on May 16, 2014. You were addressed in that transmittal and were served via email, pursuant to Commission regulations. The District did not comment on the draft. Only after Commission staff contacted the claimant representative on record by telephone after receiving no comment on the draft proposed decision did we discover that he no longer represents the District. Staff also attempted to contact your office by telephone, leaving messages with your assistant on several occasions after our knowledge of your change in representation.

Nonetheless, given that there has been a change in your representation on this matter and based on your reasons stated above, your request for postponement of hearing is approved for good cause. However, any further requests for postponement of this matter will be disfavored.

Therefore, this matter is now set for hearing on **September 26, 2014**, at 10:00 a.m. in Room 447 of the State Capitol, Sacramento, California.
