Dear Ms. Halsey:

I am writing as Claimant Representative for claimants in the two above-referenced Joint Test Claims, Nos. 09-TC-03 and 10-TC-11 ("Claimants"), over the continued, years-long delay in the issuance of Draft Proposed Decisions. The test claims were filed in 2009 and 2010, respectively, and the record in No. 09-TC-03 closed on December 19, 2016, and the record in No. 10-TC-11 closed on January 6, 2017.

As you may recall, I wrote you on the Claimants' behalf on April 16, 2018, expressing similar concern about this delay. You replied on April 19, 2018, and in that letter set forth various reasons why the test claims had not yet been set for hearing. You closed that letter by stating: "Please note that Commission staff is cognizant of the fact that these filings have been cured and complete for over a year and is working to have them and the other pending stormwater claims issued for hearing as soon as possible."

More than four years have now passed since that letter and, unfortunately, Claimants are still waiting for Draft Proposed Decisions to be issued.

As the years continue to pass, the interests of the Claimants are potentially being prejudiced. For example, Claimant personnel who might be familiar with the background

of the events giving rise to the test claim may have retired or have otherwise left the Claimants' employment.

Claimants again respectfully request that Commission staff release a Draft Proposed Decision on these Joint Test Claims as soon as possible. We specifically request that a Draft Proposed Decision on No. 09-TC-03 be released prior to July 29, 2022, so that the test claim may be heard as part of the September 23, 2022 Commission hearing calendar, and that a Draft Proposed Decision on No. 10-TC-11 be released sufficiently early to ensure a hearing before the Commission in 2022. Claimants also respectfully request that the Draft Proposed Decisions be issued reasonably far in advance of the deadline so that if any interested party requests an extension to the comment deadline, the extension will not affect staff's ability to finish a Proposed Decision in time for the scheduled Commission hearing.


