Dear Ms. Ortega,

The County of Sacramento respectfully submits comments on the Top Two Candidates Open Primary Act (Top Two) test claim. The Claimant's previous written submissions clearly show state mandated activities resulting from the cited statutes and executive orders.

Now, two years after the legislation became effective Sacramento County has incurred significant costs to meet the mandated activities. The activities and services included in the test claim meet all the tests required by mandate law. These activities and services are not a result of, or incidental to, SCA 4; rather, they result solely from legislative action. The activities and services exceed the established de minimis cost threshold.

The table below shows just some of the costs incurred to meet these requirements:
