
Dear Ms. Halsey:

The State Controller's Office's (SCO) comments for the above IRC are due January 30, 2015. We are requesting an extension of 60 days to respond.

Based on the district's filed IRC, we believed that some adjustments to the audit findings may be appropriate. We attempted to work with the district representative in an effort to resolve the issues in dispute. The district provided additional documentation to the SCO on December 19, 2014. We reviewed the records, provided our analysis, and proposed revisions to the final audit report on January 21, 2015. The district representative responded on January 29, 2015, stating that the district was not in agreement with the proposed adjustments. Unfortunately, we have reached an impasse. The additional time requested is needed to provide a formal response to the above IRC.


