On June 29, 2015, the County of San Diego (claimant) filed a test claim on the above-named matter with the Commission on State Mandates (Commission). Upon review, Commission staff found the test claim filing to be incomplete. On July, 9, 2015 Commission staff notified the claimant of several problems with the filing.

On July 15, 2015, the claimant refiled the test claim filing on the above-named matter with the Commission. Upon review, Commission staff found this test claim filing to be complete and retained the original filing date of June 29, 2015 in accordance with section 1183.1(e) of the Commission's regulations (California Code of Regulations, Title 2).




