Dear Ms. Snider:

On April 29, 2020, the Commission on State Mandates (Commission) received the claimants' 14-day request for extension of time to file rebuttal comments to the Department of Finance's (Finance's) late comments, filed January 25, 2019, and the State Water Resources Control Board's and San Diego Regional Water Quality Control Board's (Water Boards') comments, filed January 27, 2020 on the above-named Test Claim. The claimants' rebuttal comments are currently due on **May 4, 2020**.

Specifically, the request states that additional time is needed to finalize the claimants' rebuttal in light of the complexity of the issues in this matter. In addition, the request states that Ms. Snider's time has been diverted due to the emergency situation as well as due to significant discovery propounded on April 3, 2020 to the County of San Diego in the case *San Diego County Office of Education v. County of San Diego*, Case No. 34-2017-80002701.

Section 1187.9(a) of the Commission's regulations provide that so long as a postponement of a hearing would not be required, there is no prejudice to any party or interested party, and there is no other good reason for denial, the request shall be approved.

Therefore, in the interest of Commission efficiency to avoid the need to process further extension requests, a 60-day extension is approved and the claimants' rebuttal comments to both Finance's and the Water Boards' comments are now due **July 3, 2020**.

This matter remains tentatively set for hearing on **December 3, 2021**.
