Accomplice Liability for Felony Murder, 19-TC-02

Dear Ms. Halsey:

Pursuant to 2 C.C.R. § 1187.9(a), interested party the County of San Diego (the "County") requests an extension of time to submit comments to the Commission's proposed decision in the above-referenced test claim. The County requests an extension of four weeks, from July 17, 2020 to **August 14, 2020**.

The County submits this request in anticipation that it would not require a postponement of the hearing on the above-referenced test claim, which currently is tentatively set for September 25, 2020. Specifically, the undersigned has learned that Claimant LA County has requested or is in the process of requesting a postponement of the hearing to October 23, 2020. If Claimant's request is approved, then the County's request for an extension would not require a postponement of the hearing.¹

I also am not aware that this request will prejudice any other party or interested party.

This request is based on my workload in the next few weeks. I am handling two cases on behalf of the County in which the parties are currently conducting discovery, including depositions, as well as two appeals in which the County's briefs are due on July 27, 2020. I also represent the Registrar of Voters, which is busy preparing for the

November election. Finally, I am scheduled to be out of the office intermittently over the next two weeks. Thus I need additional time to finalize the County's anticipated comments on the Commission's proposed decision.
