
Dear Ms. Higashi:

On July 7, 1999, the Commission on State Mandates found that *The Stull Act* Test Claim filed by Denair Unified School District was complete. The Commission also notified the Department of Finance that its rebuttal comments, if any, were due on August 7, 1999. On August 6, 1999, the Department of Finance submitted a request for an extension of time with the Commission to file comments on the test claim. The Commission granted this request, setting October 6, 1999 as the new deadline for state agency comments. 
