**NOTICE OF REQUEST FOR EXTENSION FOR SB 1437 ACCOMPLICE LIABILITY
FOR FELONY MURDER 19-TC-02**

Pursuant to 2 C.C.R. § 1187.9(a) and (b), and for the reasons set forth below, the County of Los Angeles ("County") respectfully requests a four-week extension to August 14, 2020, to provide written comments to the Proposed Decision issued by the Commission on June 26, 2020. The County additionally requests a continuance of the scheduled hearing from September 25, 2020 to the next regularly scheduled hearing, which is December 4, 2020.

Good cause for the postponement of the hearing and the County's request for additional time to provide comments to the Proposed Decision exists because the County's Claimant Representative became unavailable due to a sudden, unexpected and lengthy leave of absence, which required the County to appoint a replacement. Additionally, the Commission's Proposed Decision requires the County's District Attorney, Public Defender, and Alternate Public Defender to collaborate with respect to the nature of the new proceedings created by the test claim. Changes in work structure due to COVID-19 protocols have made it difficult for the County departments to collaborate in drafting written comments to the Commission's Proposed Decision. The County contends it would be prejudiced if it were not provided the opportunity to provide written comments with a thorough legal analysis of the issues for the Commission's consideration.

Should the Commission allow for an extension in which to file written comments, we respectfully request a postponement of the hearing date to December 4, 2020.


