#### **Recent Decisions**

1. California School Boards Assoc., et al. v. State of California, Commission on State Mandates, et al.

California Supreme Court, Case No. S247266 (Budget trailer bills, Education Code sections 42238.24 and 56523)

On December 19, 2019, the California Supreme Court issued its opinion denying CSBA's petition. The court found that the state does not violate article XIII B, section 6 of the California Constitution when it identifies general education funding it already provides to school districts and county offices of education as offsetting revenue for the purpose of reimbursing state mandates, and that the state does not violate separation of powers principles when it allows general education funding or special education funding to be identified as offsetting revenues for state-mandated programs. This case will be remanded back to the Alameda County Superior Court to resolve the remaining issues.
