In addition, Sections VIII., IX., and X., and Items 7, 8, and 9 have been renumbered, accordingly.

Testimony at the Commission Hearings. Additionally, staff will transmit written comments filed between 15 and five days prior to a meeting to the Commission members, if possible. However, comments filed less than five days prior to a meeting or at the meeting will not be included in the Commissioners' hearing binders and the commenter shall provide 12 paper copies of the comments at the meeting.
