**EXECUTIVE SUMMARY**

On July 7, 2009, claimants requested withdrawal of the request to amend parameters and guidelines on the *Seriously Emotionally Disturbed (SED) Pupils: Out-of-State Mental Health Services* program (05-PGA-15).<sup>1</sup> Claimant's request was served in writing, and a sixty-day notice of this withdrawal and dismissal was provided pursuant to California Code of Regulations, title 2, section 1183.21.<sup>2</sup>

No interested parties objected to the claimant's request for withdrawal, or took over the claim by substitution of the parties, on or before September 29, 2009.

Therefore, the sole issue before the Commission on State Mandates (Commission) is whether the Commission adopts the Proposed Statement of Decision, dismissing the above-named request to amend parameters and guidelines.<sup>3</sup>

**Recommendation**

Staff recommends that the Commission adopt the Proposed Statement of Decision, dismissing the request to amend the parameters and guidelines for the *Seriously Emotionally Disturbed (SED) Pupils: Out-of-State Mental Health Services* program (05-PGA-15).
