¹ By statute, the SCO has up to 90 days to issue the claiming instructions and claimants have 120 days from that date to file claims. The SCO generally provides the claiming data to the Commission approximately 30 days after the deadline to file claims. In the case of programs that have ended, no claiming instructions are issued and no further claims may be filed.

² Tentative hearing dates are Commission staff's current estimate of when the matter could be set for hearing based on the currently available information regarding the complexity of the matter, workload, and staffing. A matter is only actually set for hearing when the draft proposed decision issues. Tentative hearing dates are subject to change and often do.
