The Commission on State Mandates adopted the proposed Statement of Decision for this test claim at the January 29, 2004 hearing. Due to direction from the Commissioners regarding the submission of proposed Parameters and Guidelines, release of the final Statement of Decision will be held until the hearing transcript arrives and the appropriate portions can be appended to the decision. Staff expects to issue the final Statement of Decision by the end of February.

Pursuant to Government Code section 17557, "successful test claimants shall submit proposed parameters and guidelines within 30 days of adoption of a statement of decision on a test claim." However, due to the anticipated delay, the Commission grants an extension of time to the claimant for submission of the proposed Parameters and Guidelines'30 days from the release date of the final Statement of Decision.
