

We have reviewed the revised proposed parameters and guidelines for the above named program and apologize for the late submission. Comments and recommendations follow; proposed additions are underlined and deletions are indicated with a strikethrough:

**III. PERIOD OF REIMBURSEMENT**

Government Code Section 17557, Subdivision (e), states that a test claim shall be submitted on or before June 30 following a given fiscal year to establish eligibility for that fiscal year. The San Juan Unified School District filed the test claim on June 28, 2002, establishing eligibility for reimbursement for the ~~2000-2001~~ 2001-2002 fiscal year. Therefore, costs incurred are reimbursable on or after July 1, ~~2000~~ 2001.

**COMMENT:** Test claim filed on June 28, 2002 and eligibility for that fiscal year for reimbursement is for the 2001-2002 fiscal year.
