Dear Mr. Kaye:

On April 3, 2003, the Commission on State Mandates received a proposed amendment to the test claim on *Crime Victims' Domestic Violence Incident Reports* from the County of Los Angeles.

Commission staff has reviewed this filing and determined that it is incomplete for the following reason. Pursuant to Government Code section 17564, as amended by Statutes 2002, chapter 1124, "No claim shall be made pursuant to Sections 17551 and 17561, nor shall any payment be made on claims submitted pursuant to Sections 17551 and 17561, unless these claims exceed one thousand dollars (\$1,000)...." To complete the filing, the claimant must provide a statement that actual and/or estimated costs which result from the alleged mandated exceed one thousand dollars (\$1,000) (Cal. Code Reg., tit. 2, § 1183, subd. (e) (5)).

As provided in Government Code section 17557, subdivision (c), a test claim may be amended "at any time prior to the commission hearing on the claim without affecting the original filing date as long as the amendment substantially relates to the original test claim." This claim is set for hearing on April 24, 2003. If a completed amendment is not received by the Commission before the April 24, 2003 hearing, the amendment will be disallowed.
