**LOS ANGELES COUNTY'S REQUEST FOR POSTPONEMENT OF HEARING AND
EXTENSION OF TIME TO REVISE PROPOSED PARAMETERS AND GUIDELINES
FOR CRIME VICTIMS' DOMESTIC VIOLENCE INCIDENT REPORTS II TEST CLAIM**

We request a postponement of the Commission's hearing on the above matter from October 30, 2009 to March 26, 2010. We also request an extension of time to revise our proposed Parameters and Guidelines (P's & G's) on the subject claim from October 14, 2009 to December 14, 2009.

Granting this request will give us additional time to revise our proposed P's & G's filed on October 18, 2007, to include a "new" Reasonable Reimbursement Methodology (RRM) pursuant to Government Code section 17518.5. The new RRM will include activities that are within the scope of the mandate and will reimburse local agencies for implementing the mandate in a cost-efficient manner. It will also be supported by additional and appropriate documentation. Further, a postponement will give us an opportunity to meet and confer with other local agencies in developing a State-wide Unit Cost Survey.


