Also, it has been determined that additional information is needed to complete an analysis of the claim, which has been set for hearing on **January 31, 2008**. In addition to comments by the Department of Finance, please submit the following information as soon as possible, but **not later than November 2, 2007**.

1. For each fiscal year, starting with the 2001-2002 fiscal year, please provide the total dollar amounts of State, Federal, and Local funds which comprise community college funding. In addition, please provide the percentage of community college funding that is derived from these State, Federal, and Local funds.
2. Beginning with the 2001-2002 fiscal year, were appropriations made in the State Budget for the costs (including labor, materials, contracting services, etc.) of printing community college official catalogs, schedule of classes, addenda to the schedule, and various notices? If yes, for each Budget Act, what is the specific line item and program under which these activities are funded? Please provide a copy of the relevant sections of each Budget Act.
