Dear Ms. Lawrence and Ms. Polster:

On June 26, 2003, a test claim was filed on the above named program by Mandated Cost Systems Education Services (MCSed) on behalf of the Law Office of Spector, Middleton, Young & Minney, LLP, which was authorized to represent Berkeley Unified School district and Sacramento City Unified School District, co-claimants.

On September 8, 2003, Commission staff received notice from Spector, Middleton, Young, and Minney, LLP, terminating representation of claimants for test claim 02-TC-37. On September 10, 2003, Commission staff received a notice of claimant representation for test claim 02-TC-37 from MCSed, however, this notice did not include signed authorizations to act as the representative for Berkeley Unified School District and Sacramento City Unified School District. Until the Commission receives signed statements from the test claimants authorizing MCSed to represent them during the test claim process, MCSed has no authority to act on claimants' behalf.

The Commission staff is currently working on test claim 02-TC-37 and expects to issue a draft staff analysis in the near future. As a result, the Commission is now requesting claimants to identify the party or parties that will represent them during the test claim process.


