The State Controller's Office (SCO) reissued its audit report of the legislatively mandated Firefighter's Cancer Presumption claim filed by the city for fiscal year 2003-04, on April 26, 2016. The revised audit report allows the disability benefit costs previously identified as unallowable and challenged by the city in the above referenced IRC. Therefore, the city is no longer challenging the SCO audit adjustment.


