This Office represents the County of San Diego ("County") in the consolidated matter pending with the Commission on State Mandates ("Commission") referenced above. Pursuant to California Code of Regulations, title 2, section 1187.9 (a), the County respectfully requests a brief extension of time to file comments on the proposed decision on this matter. The parties' comments are due on April 5, 2016. I and others familiar with this matter need to attend to an urgent legal issue that requires our full attention. In addition, we are experiencing an unusually high workload that prevents the County from submitting a thorough response to the proposed decision. Furthermore, the instant matter before the Commission is complex in nature and requires significant legal analysis.


