Request For 30-Day Extension to Respond To Staff Analysis, And For One-Meeting
Continuance Of Commission Hearing

Dear Executive Director Halsey:

Pursuant to Title 2, California Code of Regulations, section 1183.01(c)(1) and (c)(2), Claimant Los Angeles Unified School District ("LAUSD") respectfully requests an extension of time of 30 days (to January 17, 2014 from present date of December 18, 2013) in which to submit a response to the November 27, 2013 Staff Analysis issued in the within matter. LAUSD concurrently requests a one-meeting continuance of the January 24, 2014 Commission hearing.

It is respectfully submitted that good cause exists for the granting of the requested extension and continuance, as follows:

1. The Staff Analysis is very detailed and requires substantial review, analysis, and fact-gathering on behalf by Claimant LAUSD in order to prepare an adequate response to the Staff Analysis, and to prepare for hearing following issuance of any revised Staff Analysis.
2. It is holiday seasons and LAUSD will be closed for the Winter Recess. During this time period, it will be very difficult for LAUSD to gather the required information, prepare a proper response to the Staff Analysis, and thereafter prepare for hearing due to the time constraints involved.
3. Additionally, counsel for LAUSD will also be unavailable during portions of the time period at issue due to travel, and due to other filings. Among other things, Counsel for Claimant has a Reply Brief due in the California Supreme Court on December 19, 2013.

It is respectfully submitted that good cause exists for the requested extension and continuance.


