I am the Acting Director of Finance for the City of Hayward. I replaced Juliana F. Gmur (MAXMUS, Inc.) as the claimant's sole representative in the above referenced incorrect reduction claim (IRC). The City respectively withdraws the above referenced IRC pursuant to Title 2 of the *California Code of Regulations*, section 1185.8.

Consistent with the proposed decision, the State Controller's Office is reinstating the construction adjustment in Finding 2 for fiscal year (FY) 1998-99 totaling \$40,385 and the equipment adjustment in Finding 9 for FY 2005-06 totaling 16,309. The city has no further documentation in support of the audit adjustments.


