This office represents the County of Orange in the above-referenced Incorrect Reduction Claims currently pending with the Commission. The Controller filed his comments on our claims on October 3, 2014. Accordingly, we have the opportunity to submit a rebuttal to his comments by November 3, 2014. (Cal. Code Regs. tit. 2, § 1185.2, subd. (c).)

Given the time between the filing of our claims on November 17, 2011, and the filing of the Controller's comments, the County will naturally need an opportunity to revisit the claims, review the Controller's comments, and provide a thorough rebuttal using currently assigned staff (some staff, including me, was not assigned to this matter in 2011). We ask that the Commission continue the due date for our rebuttal to February 3, 2015.
