Dear Ms. Halsey:

Pursuant to Title 2, California Code of Regulations, section 1183.01(c)(1) and (c)(2), Claimant Stanton Housing Authority (“Authority”) respectfully requests an extension of time of 45 days (to April 7, 2014 from the current deadline of February 21, 2014) in which to submit a response to the January 31, 2014 Staff Analysis issued for 12-TC-03. The Authority concurrently requests a one-meeting postponement of the March 28, 2014 Commission hearing on 12-TC-03 to the May 30, 2014 Commission meeting.

It is respectfully submitted that good cause exists for the granting of the requested extension and continuance due to the complexity of the Staff Analysis, which is very detailed and requires substantial review, analysis, and fact-gathering on behalf of the Authority in order to prepare an adequate response to the Staff Analysis, and to prepare for the Commission hearing. Additionally, because of the Authority’s limited budget, Authority staff is limited and unable to analyze the multiple statutes involved and the issues presented in the Staff Analysis by the current deadline.
