On September 20, 2016, the Commission on State Mandates (Commission) received a request from Mr. Tunick to expedite the above-captioned Incorrect Reduction Claims (IRCs). The request indicates that the firm of Dannis Woliver Kelley represents two claimants, among several others, the Long Beach Community College District and the San Mateo County Community College District. In addition, it explains that many of the claims will raise common issues which will likely be addressed in the first decision on this program issued by the Commission. Finally,

Mr. Tunick requested that the IRCs of claimants represented by your firm be considered prior to other claims, in particular, prior to the claim filed by the Citrus Community College District.

Following review, Commission staff finds that the firm of Dannis Woliver Kelley has not been designated as the claimant representative for Long Beach Community College District. Dannis Woliver Kelley is, however, designated as claimant representative for San Mateo County Community College District, 15-0007-I-12. The IRC filed by Citrus Community College District on this program and presumably referred to in Mr. Tunick's letter is *Integrated Waste Management*, 14-0007-I-03. In future correspondence with the Commission, please always include the matter number in order to facilitate the processing of your requests.


It is the practice of the Commission to adhere to the first-in-time policy, unless circumstances justify an exception. The following are strategies the Commission employs to more efficiently decide matters, with a goal of eliminating the backlog as soon as possible: (1) claim consolidation; (2) common issues; (3) simple test claims and single-issue IRCs; (4) stakeholder requests; and (5) joint RRM's. The Commission has also taken matters out of order for staff development purposes. Commission management has also, on occasion, assigned less-complicated matters out of order to a staff person who has just completed a particularly difficult assignment. This increases the opportunities for staff to gain experience in a wide variety of legal matters and prevents staff burnout.

The next two IRCs on the *Integrated Waste Management* program that are tentatively scheduled to be heard are 13-0007-I-02, and 14-0007-I-03, both of which raise the same cross-cutting issues as San Mateo's 15-0007-I-12, which was the very last IRC filed on this program, and is currently scheduled last. Therefore, there is no reason to move 15-0007-I-12 ahead in the queue, since that would be unfair to other claimants who have been waiting longer for their matters to be heard. Moreover, staff assignments have been given and work has begun on the pending matters for October and January and changing the order of hearing at this time would cause further delay and disrupt the Commission's workflow.

Therefore, your request to expedite these two IRCs is denied.

However, as representative of San Mateo County Community College District, you are welcome to participate in the process, and submit comments fully briefing the issues, as an interested party on the first IRCs to be heard on this program. If you have not done so already, you may request to be added to the mailing lists for the other *Integrated Waste Management* IRCs so that you receive the draft proposed decisions for your review and comment and any other correspondence on these matters as they move forward.


