
Dear Ms. Halsey:

The State Controller's Office (SCO) has reviewed the proposed decision for the above IRC.

The proposed decision recommends partial approval of the IRC and that the SCO reinstate \$35,967 plus indirect costs. In hindsight, we agree that costs actually supported by the district should have been allowed. However, as noted in PDF page 116 of the SCO's response to the IRC dated March 27, 2015, the \$35,967 includes indirect costs. Therefore, we support the reinstatement of \$35,967 only, as this amount includes the indirect costs.


