Dear Mr. Newmark:

On March 6, 2018 the Commission on State Mandates (Commission) received the claimant's request for extension of the 30-day rebuttal period provided in section 1183.3 of the Commission's regulations to 45 days from the date of service of the San Francisco Regional Water Quality Control Board's Late Comments on the Test Claim and the Administrative Record on Order No. R2-2015-0049, both served on February 9, 2018.

Specifically, the request states that the comments submitted by the Regional Board are numerous, lengthy, and detailed, and the evidence submitted in support of the comments is voluminous, necessitating additional time to review, analyze, and address the extensive comments and evidence. The Administrative Record filed for this matter is in fact nearly 138,000 pages long.

Section 1187.9(a) of the Commission's regulations provide that so long as a postponement of a hearing would not be required, there is no prejudice to any party or interested party, and there is no other good reason for denial, the request shall be approved.

Therefore, claimant's rebuttal comments are now due **March 26, 2018**. This matter is now tentatively set for hearing on March 22, 2019.
