This letter is submitted on behalf of the City of Union City, the Claimant in the above-captioned test claim, regarding the Regional Water Board's Comment Letter electronically served on February 9, 2018, and the Department of Finance's (Finance) comment letter dated October 10, 2017. We are writing to request an additional extension of time to provide Union City's combined rebuttal to both comment letters. Specifically, we request an additional 30-day extension of time to submit a combined rebuttal package on or before May 28, 2018.

This request is supported by good cause primarily due to the number and complexity of the issues raised and the volume of evidence submitted by the Regional Water Board. Though we still intend to make our comments succinct, we nevertheless require an additional extension to continue our efforts in that regard. In addition, I am a party representative, and I have been unavailable for much of the last extension period because I have been engaged in court-ordered mediation proceedings. Given that many earlier-filed storm water test claims have still not been heard, we do not believe any party would be prejudiced by the extension we are requesting.
