Dear Ms. Halsey:

I am writing this letter on behalf of test claimants Riverside County Flood Control and Water Conservation District, County of Riverside and the Cities of Murrieta, Temecula and Wildomar ("Joint Test Claimants") to request an extension of time to **March 15, 2019** for the filing of rebuttal comments on the test claim. I am the designated Claimant Representative for all Joint Test Claimants. The rebuttal comments are currently due to be filed on **January 15, 2019** with respect to the comments of the Department of Finance and the State Water Resources Control Board and the San Diego Water Board.

Due to the number of issues in this Joint Test Claim and the need for Joint Test Claimant representatives to review the rebuttal documents, the Joint Test Claimants are requesting the above-noted extension of time. Joint Test Claimants do not at this time anticipate requesting further extensions.

The Commission is presently scheduled to hear this test claim on September 25, 2020.
