Dear Ms. Chinn:

On April 7, 2020 the Town of Apple Valley (claimant) filed a request with the Commission on State Mandates (Commission) for a 30-day extension to file comments on the Draft Proposed Decision, currently due April 7, 2020, and for postponement of the May 22, 2020 hearing on the above-captioned Incorrect Reduction Claim (IRC).

Specifically, the claimant requests an extension of time to May 7, 2020 and for postponement of the hearing due to staff being adversely affected by the COVID-19 virus, making it not possible to review and respond to the Draft Proposed Decision by the original deadline.

Section 1187.9(b) of the Commission's regulations provide that while postponements are disfavored and pursuant to Government Code section 17530, the executive director has a duty to expedite all matters before the Commission, a request for postponement filed by the claimant at least 15 days before the hearing shall be approved for good cause. (Cal. Code. Regs., tit. 2 § 1187.9(b).)

Therefore, the request for extension of time to file comments on the Draft Proposed Decision, and for postponement of hearing is approved for good cause pursuant to section 1187.9(a) and (b)(1)(A) and (b)(3)(A) of the Commission's regulations. The claimant's comments on the Draft Proposed Decision are now due **May 7, 2020** and this matter is now set for hearing on **July 24, 2020**.
