Dear Mr. Barry:

On February 6, 2019, the Commission on State Mandates (Commission) received the claimants' request for an extension of time to file rebuttal comments to the Department of Finance's (Finance's) Late Comments on the above-named Test Claim, currently due on February 27, 2019.

Specifically, the claimants request to file rebuttal comments to both Finance's Late Comments on the Test Claim, served on January 28, 2019, and the Water Boards' comments on the Test Claim and administrative record on the Order, currently due on March 29, 2019, 30 days from the service of the Water Boards' comments and administrative record.

Section 1183.3(a) of the Commission's regulations provide that written rebuttals to written comments concerning a test claim may be filed, and shall be certified, filed, and served in accordance with section 1181.3 of these regulations within 30 days of service of the written comments.

Section 1187.9(a) of the Commission's regulations provide that so long as a postponement of a hearing would not be required, there is no prejudice to any party or interested party, and there is no other good reason for denial, the request shall be approved.

Therefore, the claimants' request for extension to file all rebuttal comments until 30 days from the service of the Water Boards' comments and administrative record on the Order is granted pursuant to sections 1183.3(a) and 1187.9(a) of the Commission's regulations.

This matter remains tentatively set for hearing on **January 22, 2021**.


