Dear Ms. Calciano and Mr. Montgomery:

On February 20, 2020, the Commission on State Mandates (Commission) received the City of Chino Hills' (claimant's) request for a 90-day extension of time to file rebuttal comments to the Department of Finance's (Finance's) Late Comments and to the State Water Resources Control Board's and the Santa Ana Regional Water Quality Control Board's (Water Boards') comments on the above-captioned Test Claim, currently due on **March 5, 2020**.

Specifically, the request states that the claimant needs more than a month to review and respond to both Finance's and the Water Boards' comments.

Section 1187.9(a) of the Commission's regulations provide that so long as a postponement of a hearing would not be required, there is no prejudice to any party or interested party, and there is no other good reason for denial, the request for extension shall be approved.

Therefore, the request for an extension to file rebuttal comments to both Finance's and the Water Boards' comments on the above-captioned Test Claim is granted pursuant to section 1187.9(a) of the Commission's regulations. As requested, the claimant's rebuttal comments to Finance's and the Water Boards' comments are now due May 27, 2020.

Please be reminded that none of the Test Claims, 17-TC-07 - 17-TC-28 have been consolidated. The decision on whether to consolidate any or all of these matters for hearing will be made by the executive director once comments have been filed and the records are thoroughly reviewed for analysis and hearing.
