Dear Mr. Burgh, Mr. Hughes, and Ms. Kato:

On November 18, 2025, the County of Ventura (claimant) filed the above-captioned Incorrect Reduction Claim (IRC) with the Commission on State Mandates (Commission) based on the State Controller's (Controller's) reductions to its reimbursement claims for costs incurred under the *Child Abduction and Recovery* program for fiscal years 2016-2017, 2017-2018, 2018-2019, 2019-2020, in accordance with Government Code section 17551(d). Upon review, Commission staff found the IRC to be incomplete and on December 4, 2025, notified the claimant. On December 4, 2025, the claimant filed documents to cure the IRC. Upon review, Commission staff finds that this IRC is complete and that it retains the filing date of November 18, 2025, in accordance with section 1185.2(a) and 1181.2(e), effective January 1, 2026 of the Commission's regulations (California Code of Regulations, Title 2).

Controller's Review and Response. The Controller's written comments and supporting documentation regarding this claim are due no later than **March 11, 2026** in accordance with Government Code Section 11020 and sections 1181.2(e), effective January 1, 2026, 1185.2(d) and 1187.5 of the Commission's regulations. Please include an explanation of the reasons for the reductions and the computation of reimbursements.

The failure of the Controller to respond within this 90-day timeline shall not cause the Commission to delay consideration of this IRC. (Gov. Code §17553(d).)

Claimant's Rebuttal. Upon receipt of the Controller's comments, the claimant and interested persons may file rebuttals. The rebuttals are due 30 days from the service date of the comments (Gov. Code § 11020 and Cal. Code. Regs., tit. 2 § 1185.2(e), effective January 1, 2026.) If new written representations of fact are made, they must

be supported with documentary evidence filed with the rebuttal. (Cal. Code. Regs., tit. 2 §§ 1181.3, 1185.2(e), effective January 1, 2026, and 1187.5.)

Requirements for All Filings and Testimony. All oral or written representations of fact made to the Commission offered by any person shall be under oath or affirmation and signed under penalty of perjury by persons who are authorized and competent to do so and must be based on the declarant's personal knowledge, information or belief. (Cal. Code. Regs., tit. 2 §§ 1185.2(e), effective January 1, 2026, and 1187.5.) The Commission's ultimate findings of fact must be supported by substantial evidence in the record.¹ Hearsay evidence (such as declarations not based on personal knowledge but information and belief alone) may be used for the purpose of supplementing or explaining other evidence but shall not be sufficient in itself to support a finding unless it would be admissible over objection in civil actions.²

Filing Written Materials. The Commission's regulations require that written materials filed with the Commission be electronically filed (e-filed) in an unlocked legible and searchable PDF file, using the Commission's Dropbox. (Cal. Code Regs., tit. 2, §§ 1181.3(d)(2) and 1181.3(f), effective January 1, 2026.) Refer to https://www.csm.ca.gov/dropbox.shtml on the Commission's website for electronic filing instructions. If e-filing would cause the filer undue hardship or significant prejudice, filing may occur by first class mail, overnight delivery or personal service only upon approval of a written request to the executive director. (Cal. Code Regs., tit. 2, 1181.3(j), effective January 1, 2026.)

If you would like to request an extension of time, please refer to section 1187.9(a) of the Commission's regulations.

Informal Conference. An informal conference may be scheduled if requested. Refer to section 1187.4 of the Commission's regulations.

Public Hearing and Draft Proposed Decision. The public hearing on this Incorrect Reduction Claim has been tentatively scheduled for **October 9, 2026.** The Draft Proposed Decision will be issued for comment at least eight weeks prior to the public hearing.
