Commission staff received a fax transmission requesting the addition of your name to the mailing list for this test claim. Prior to receipt of your letter, the attached letter was issued by first class mail to the mailing list confirming your earlier request via phone call.

Your October 24, 2006 letter also requested an extension of time to comment on the draft staff analysis; however, this request does not comply with the Commission's regulations. Among other things, "[s]uch request shall fully explain the reason(s) for the extension, propose a new date for filing, and be simultaneously served on" the mailing list.

In addition, a request for extension of time that results in the need to reschedule the hearing date must also include a request for postponement of the hearing, pursuant to section 1183.01, subdivision (c)(2), of the Commission's regulations. The final staff analysis is scheduled to be issued on November 22, 2006, in order for the item to be heard on the December 4, 2006 agenda. The next scheduled Commission hearing date is January 25, 2007, with a comment period ending no later than December 29, 2006.
