Dear Mr. Kaye:

Claimant's March 10, 2003 request for an extension of time to respond to the draft staff analysis 30 days after the California Supreme Court issues its decision in *Department of Finance v. Commission on State Mandates, et al.*, Case Number C037645 (*School Site Councils*), is denied.

The claimant has not pled any of the elements of "good cause," as defined in section 1181.1, subdivision (g), of the Commission's regulations. Further, it is not good cause to continue a test claim simply because of pending litigation in other cases. The statutes at issue in the *Department of Finance* case are not at issue here. Moreover, the claimant has the right in this case to commence a proceeding in accordance with Government Code section 17559 to set aside the Commission's decision if the claimant believes the decision is contrary to law. Thus, good cause has not been established.

The claimant may appeal the decision of the Executive Director to the Commission pursuant to California Code of Regulations, title 2, section 1181, subdivision (c).
