On January 12, 2018, the Commission on State Mandates (Commission) received the County of San Diego (claimant) request for an extension of time to submit rebuttal comments on the above-captioned Test Claim.

Specifically, the request states that the claimant requires a 60-day extension beyond the current deadline of January 23, 2018 to file rebuttal comments on the Test Claim due to the complexity and length of the comments and administrative record filed by the Waterboards, limited staff availability, and competing workload priorities.

Section 1187.9(a) of the Commission's regulations provide that so long as a postponement of a hearing would not be required, there is no prejudice to any party or interested party, and there is no other good reason for denial, the request shall be approved.

Therefore, Claimant's response is now due **March 23, 2018**.

In addition to other matters pending before the Commission, this matter's tentative hearing date has been updated. This matter is now set for January 25, 2019.


