Pursuant to 2 C.C.R. § 1187.9(a) and (b), and for the reasons set forth below, the County of San Diego ("County") respectfully requests a continuance of the tentatively scheduled hearing from July 26, 2019 to October 25, 2019. The County additionally requests that it be granted at three weeks, to August 2, 2019, to provide written comments to the Proposed Decision issued by the Commission on July 12, 2019.

Good cause for the postponement of the hearing and the County's request for additional time to provide comments to the Proposed Decision exists because the Commission's Proposed Decision raises two additional independent grounds for rejection of the County's test claim that were neither advanced by the Department of Finance nor addressed in the March 25, 2019 Draft Proposed Decision. In particular, the July 12, 2019 Proposed Decision includes significant new discussion relating to Government Code section 17556 subsections(c) and (g). Due to the complexity of the issues raised by the new discussion in the Proposed Decision, the County contends it would be prejudiced if it were not provided the opportunity to provide written comments with legal analysis of the new issues for the Commission's consideration.
