Dear Ms. Hagan:

On August 18, 2017, the Commission on State Mandates (Commission) received the California Regional Water Quality Control Board, San Diego Region and the State Water Resources Control Board (collectively Water Boards) second request for an extension of time to file the administrative record and comments on the above-captioned Test Claim.

Specifically, the request states that the Water Boards require another 45-day extension beyond the current deadline of August 25, 2017 to file written comments on the Test Claim and to prepare the administrative record for the permit due to competing workload requirements on other test claims before the Commission and providing assistance to the Attorney General's Office with litigation matters.

Section 1187.9(a) of the Commission's regulations provide that so long as a postponement of a hearing would not be required, there is no prejudice to any party or interested party, and there is no other good reason for denial, the request shall be approved.

Therefore, Water Boards' response is now due **October 9, 2017**.

In addition to other matters pending before the Commission, this matter's tentative hearing date has been updated. This matter is now tentatively set for September 28, 2018.

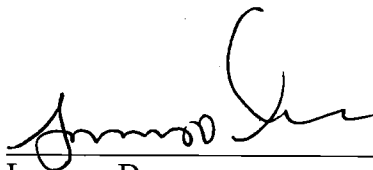
