          The Commission's budget is set for hearing in the
     Senate Budget Subcommittee 4 on March 30th and in the

     Assembly Budget Subcommittee 4 on April 18th.

The Commission's budget, as proposed by the 1 2 Governor, is \$2,192,000, which is slightly higher than 3 the current year, to account for general salary increases approved by the Legislature and unavoidable increases in 5 operating costs. 6 My report has listed out the mandated programs 7 proposed to be funded and suspended in the Governor's 8 budget; and those are in my report if you are interested 9 in looking at them. 10 There was one interesting item, though, which is for 11 ICAN, the Interagency Child Abuse and Neglect Investigation Reports. That program is proposed for 12 13 suspension but is also proposed to be funded through an optional block grant. 14 15 Generally, local agency mandates were funded through the Commission's budget. However, the Governor's 16 17 proposed budget makes \$4 million available in county 18 optional block-grant funding through the Department of 19 Social Services for allocation to local agencies to fund 20 the reimbursable activities under ICAN. 21 (Mr. Chivaro entered the meeting room.) 22 MS. HALSEY: Local governments that receive the 23 block-grant funding are not eligible to claim cost under

Section 17560 of the Government Code for any costs

associated with the program. And the Department of

Social Services is working in consultation with CSAC to develop an allocation methodology for distributing those funds to participating counties.

And that's what I have on budget.

Then for workload, after this hearing, we have

15 test claims, all but one of which are regarding the

National Pollutant Discharge Elimination System, or

NPDES, Permits; and one parameters and guidelines; and
one statewide cost estimate, also regarding NPDES Permits
is pending.

In addition, we have one parameters and guidelines amendment on inactive status pending the outcome in the CSBA litigation, which is now in the First District Court of Appeal.

And finally, we have 16 IRCs remaining.

As of today, the Commission staff expects to complete all currently pending test claims and IRCs by approximately the September 2018 Commission hearing, depending on staffing and other workload.

For the test claims on *Stormwater*, that's what everyone is working on now, and that's one of the reasons why this hearing is so light. There are a number of very complex issues. The records are huge and growing.

Just for an example, we needed some additional evidence on one issue for one claim; and we just received

a 40,000-page supplement to the record for one of the 1 2 items that's being currently worked on. So that's the 3 kind of stuff we're dealing with, where that will take 4 staff every bit of all day just to make sure that the 5 filing is legible and that all the pages are complete, let alone to understand the substance of what's in it. 6 7 So it's kind of like trudging through the mud. You 8 know, a slow slog. But we are making progress. 9 And I expect to have, hopefully, at least one or 10 more of these set for July. 11 And that's all I have. 12 MEMBER OLSEN: It's too bad they don't come in an 13 audible version. We commuters in L.A., that's how we get our reading taken care of. 14 15 CHAIR ORTEGA: And I just wanted to commend staff on the IRCs. I remember when I first started chairing the 16 board and how many there were; and to have it down to 17 18 16 is incredible and great work. So I really appreciate 19 that. 20 I think that's it, right, for our regular items. Please note for the record that Mr. Chivaro has 21 22 joined us. 23 So the Commission will meet in closed executive 24 session pursuant to Government Code section 11126(e) to 25 confer with and receive advice from legal counsel for

consideration and action, as necessary and appropriate, 1 upon the pending litigation listed on the published 2 3 notice and agenda; and to confer with and receive advice from legal counsel regarding potential litigation. 4 5 The Commission will also confer on personnel matters pursuant to Government Code section 11126(a)(1). 6 7 We will reconvene in open session in probably 8 five minutes. 9 Thank you, everyone. 10 (The Commission met in closed executive session 11 from 10:12 a.m. to 10:22) 12 CHAIR ORTEGA: We're going to reconvene in public 13 session. The Commission met in closed executive session 14 15 pursuant to Government Code section 11126(e)(2), to confer with and receive advice from legal counsel for 16 17 consideration and action, as necessary and appropriate, 18 upon the pending litigation listed on the published 19 notice and agenda; and to confer with and receive advice 20 from legal counsel regarding potential litigation; and 21 pursuant to Government Code section 11126(a)(1), to 22 confer on personnel matters. 23 And I don't see any public comment. So with no further business, we will be adjourned. 24 25 (The Commission meeting concluded at 10:22 a.m.)
